2024 Minimum Wage Mid-Year Updates

The states and municipalities highlighted in the following Guide will increase the minimum wage as of July 1 or in the second half of 2024.

Employers in states without minimum wage laws, or with minimum wage rates lower than the federal minimum wage, which is currently \$7.25 an hour, must observe the federal minimum wage for all ees covered by the Fair Labor Standards Act. States that permit tip credits require employers to ensure that the ees' tips and the reduced hourly wage rate equal at least the required minimum wage rate and must keep accurate records of ees' tips. Check your local laws to confirm compliance.
